Sub: Schedule for the revision of electoral rolls for general/ bye elections to the Municipal Corporations (i.e. Barnala, Bathinda, Abohar, Batala, Hoshiarpur, Kapurthala, Moga, S.A.S Nagar and Pathankot) and 104 Municipal Councils/ Nagar Panchayats in the State of Punjab – regarding.

In exercise of the powers conferred under Rule 3 of the Punjab Municipal Election Rules, 1994, the Commission issues the following programme for the revision of electoral rolls in respect of the Municipal Corporations, Municipal Councils and Nagar Panchayats, falling in your district (**Annexure-1**) and as per the detail regarding Delimitation as provided by the Director, Local Government, vide their letter no. 04/01/2024/ਮਚਦ/ਰਸ/30421, dated 07.04.2026, (copy enclosed at **Annexure-2**): -

2. The schedule for revision of electoral rolls is to be followed scrupulously. The Registration Officer shall be responsible for revising the roll in respect of all or any constituency or part thereof, of the Municipalities of which he is the Registration Officer. He shall strictly abide by the Rules as contained in Part II (Preparation of Electoral Rolls) of the Punjab Municipal Election Rules, 1994.

3. For the purpose of revision of electoral rolls for the Municipal Corporations, Municipal Councils/ Nagar Panchayats, the qualifying date shall be **23.04.2026**, i.e. all the persons who have completed prescribed age i.e. 18 years on **23.04.2026**, shall be eligible to have their names registered as voters, if applied for. Suitable number of claim application forms may be kept at the office of the ERO.

4. The Registration Officer may ensure to suitably publicize the copy of both the Draft Roll, as well as the electoral roll as finally prepared for Municipal Corporations, Municipal Councils/ Nagar Panchayats, on 05.05.2026, and make it available for inspection to the general public at his office, at the office of the Municipalities concerned, and at any other place specified by him.

5. The said programme may be brought to the notice of all concerned, through wide publicity.

6. Intimation to the effect that the draft electoral rolls have been published may be sent to the Commission immediately. Further, intimation to the effect that the final electoral rolls have been published may be sent to the Commission on completion.






